- Single Audit Update: Maner Costerisan notified that the MOISD Audit was positive.
- Great Start Collaborative 32p Outlook
 - One position: Business Office assistance and social media efforts expanding.
 - One position: Family & Support Services at MSCS funded through 31n.
- Construction Trades House
 - Mechanic Street house nearing completion; walkthrough scheduled
 - Second Street duplex: concrete phase underway. Bid challenges noted; rebidding
- Proposed School Board Finance Training: EPS & MOISD
- School Finance Software Transition – Full changeover will be in April
 - All local districts are moving to Skyward Finance.
 - Potential MOP Business Services Position Discussion.
- New SE Supervisor to serve as primary US-10 supervisor and ISD-wide Transition Coordinator.
- Maintenance Directors Meeting: The first meeting was hosted by MOISD and received very positive feedback.

This agreement will be effective from December 8, 2025, through June 4, 2026 (2025-2026 School Year). Services will not exceed \$45,920.00. **Motion carried unanimously.**

Action Item No. 21 – Consideration and Approval of Resolution for Conditional Opt-In for 31aa

Funds. Member Stickler made a motion, supported by Member Tiedt, that the MOISD Board of Education approve Option A.
