SECTION 1: INTRODUCTION

The Mecosta-Osceola Intermediate School District (MOISD) invites qualified vendors to submit proposals for the replacement of a single Make-Up Air Unit (MUA) and associated HVAC system components at the Mecosta-Osceola Career Center (MOCC). The successful bidder must comply with all applicable Michigan laws, policies, and codes governing educational facility infrastructure improvements and procurement processes.

MOISD seeks proposals for the replacement and installation of a single Make-Up Air Unit (MUA) at MOCC. The project includes the removal of the existing unit, installation of a new high-efficiency MUA, and integration with existing HVAC infrastructure.
