# 1. Introduction

The Mecosta-Osceola Intermediate School District (MOISD) seeks qualified vendors to supply and install a preschool playground structure suitable for young children (approximately 2-5 years). The proposed structure must be comparable in design, features, and functionality to the GameTime Kilpatrick PT24002 model. All equipment and installation must comply with Michigan's Great Start Readiness Program (GSRP) licensing requirements.

# 2. Project Overview

- Location: Hillcrest Early Childhood Center. 501 W. Bridge St. Big Rapids, MI 49307
- Target Age Group: Children aged 2-5 years
- Project Scope:
  - Supply and install a preschool playground structure as detailed below
  - Site preparation and ADA-compliant installation
  - Post-installation inspection and certification by all relevant authorities

# 3. Product Specifications

### **Comparable Model Requirement:**

The structure must be comparable to GameTime's Kilpatrick PT24002, offering equivalent features, layout, size, accessibility, and safety.

The vendor must demonstrate in their proposal how their product meets the specifications and features of the GameTimes's Kilpatrick PT24002 structure.

### Dimensions & Safety Zones:

- Use Zone: Minimum of 6 ft clearance around equipment; extra per CPSC guidelines for slides/swings
- Fall Height: Maximum 60 in (5 ft)

### Accessibility:

• ADA-compliant elevated and ground-level components

### Compliance:

- ASTM and CPSC safety standards
- ADA compliance
- Michigan Admin Code R 400.8170(11) and 2010 CPSC Public Playground Safety guidelines
- Post-installation inspection/certification per MiLEAP requirements
